City Administrator & Long Range Plan Committee Report. City Administrator Gorius provided a written report regarding current and ongoing activities. 1. Attended the Library fundraiser. 2. Attended the Volk Field Holiday event. 3. Working on AFSCME negotiations. 4. Thanked City crews for their dedication by working during City holiday events.

City Clerk. There will be no February Primary election. Had the drawing for placement on the Spring election ballot. Reconciliation of the November election is almost complete. Working on the personnel policy manual revision and implementation of an employee vision program.

Library Monthly Report. The annual tea and fundraiser was a success. Director Keller thanked Margie Gigous for organizing the event and local businesses for donating. A large screen for library movie events will be purchased with the proceeds. The Library will take part in Freeze Fest by hosting a family movie night.

Convention & Visitors Bureau/Chamber of Commerce. Director Thompson reported that the Chamber's 2019 Promotion theme is "Beyond the Bog" and will present that our community has more to offer than the local cranberry industry. The 2019 Area Guide is out for print and will be available at the annual awards banquet. The new CVB logo will be unveiled at the banquet as well. A variation of the logo will be used by the City. The Chamber is working with Tomah High School and other groups regarding the lack of workforce and how to promote the area to attract and keep workers. Director Thompson reminded everyone who is interested in attending the banquet to order tickets as soon as possible as it does sell out.

Tomah Public Housing & Community Development Block Grant Monthly Report. None.

Senior & Disabled Services Report. Pam Buchda, Senior & Disabled Services Coordinator provided a monthly calendar and summary of events. A music program was held on January 4th. United Health Care has committed to sponsoring monthly Bingo Bash events for one year which will provide \$600 to that program. A Snow Buddies project will be held Jan. 29th. The Senior Center will take part in Freeze Fest by hosting bingo and euchre on Friday, Feb. 1st as well a potluck meal. AA meetings are now being held at the Senior Center on Wed. evenings at 5:30 p.m. The awning project is in progress. The center will host an Alzheimer's Community Forum on January 5th. The next Senior and Disabled Services board meeting will be held at 6:30 p.m.on January 28th. Sunday Fun Day for special needs individuals and their families will be on Jan. 27th from 2-4PM.

Planning/Building Inspection Monthly Report. Shane Rolff provided a written report. There were 394 building permits issued in 2018. Total project valuation was \$65,327,015.00 with \$159,656.00 collected in fees.

Parks & Recreation Monthly Report–Recreation Programs, Aquatic Center, Recreation Park. Director Joe Protz provided a report summarizing department activities. Rec. staff is working on equipment and building maintenance. Men's league basketball continues with 13 teams playing on Wednesday evenings. The outdoor skating rink at Rec. Park is being flooded. and staff is continuing to work on snow removal. Freeze Fest will be held February 1st and 2nd and a floorball tournament is scheduled for April 13th. Builders Agreement 3rd Gen, LLC. The Builders Agreement between the City and 3rd Gen. states that upon the issuance of a Certificate of Occupancy, the City will issue a loan to 3rd Gen LLC in the amount of \$1.25 million. The City has received a \$250,000 grant for blighted property to improve the parking lot behind the building. Although the grant was included in the loan amount, 3rd Gen LLC understood that they would receive the \$250,000 grant in addition to the \$1.25 million loan from the City. Since the City had the intention of providing \$1.25 to 3rd Gen LLC and the improved parking situation would benefit citizens as well as various entities and businesses in the City, it is recommended the City borrow the additional \$250,000 for 3rd Gen LLC to make the total amount whole at \$1.5 million.

Motion by Cram, second by Gomez to approve borrowing an additional \$250,000 from the State Trust Fund to make whole the \$1,500,000 that was intended for 3rd Gen, LLC at the current interest rate. Motion passed with one negative vote (Yarrington).

Motion by Yarrington, second by Scholze to adjourn. Motion passed without negative vote. The meeting adjourned at 8:15 p.m.
