

MEETING MINUTES - CITY OF TOMAH

A meeting of the **Parks & Recreation Commission (PRC)** for the City of Tomah was held on Monday the 24th day of June 2019 at 5:45 p.m., City of Tomah Council Chambers

Others present: Lamont Kiefer chaired the meeting.

Act on Minutes of regular meeting. A motion by Tessman to accept the minutes of the Apr 29, 2019 regular meeting, second by Evans. All ayes. Motion carried.

Food truck parking at Farmer's Market: City Hall has had a few inquiries about selling at the Famer's Market from Food Truck vendors. Currently vendors cannot park on Holton St. To date, Food Truck Vendors have been instructed to park on the west side of Kilbourn St between Holton and Council Streets. Dir Protz initiated a discussion about to handle additional requests and where to locate the trucks. No formal action taken. PRC will continue to monitor the situation and demand and act accordingly.

Geese in Winnebago Park: Geese continue to return to Winnebago each year and continue to be a nuisance to park users and leave droppings across the property and PRC has been receiving complaints from the community amid concerns of potential health risks. Dir Protz led a general discussion of the situation and potential actions to limit geese in the park. Geese are a common problem for municipalities. Many ideas were brainstormed. The Winnebago Park Master Plan will assemble attempt to address the concerns. No formal action taken.

Update on Winnebago Park Master Plan: CBS2 (Squared) will present conceptual ideas at the July 22, 2019 PRC meeting which will be held at the Winnebago Park Shelter. Current plan is for CBS2 and the PRC to hold an open house on August 26, 2019. Dir Protz updated the PRC on discussions that have occurred between CBS2 and the City (Park and Rec Dept).

Parks and Rec Program Report: Dir Protz reviewed the June 2019 Park and Rec Program report. All summer programs are underway. Parks staff continue to clean, maintain, and prep for activities all the Park resources. The schedule for Rec Park continues remains full well into the fall.

Other Affairs: -

Motion by Peth to adjourn, second by Tessman. All ayes, motion carried. Meeting adjourned at 6:40 PM. Next regular monthly meeting to be held Monday, July 22, 2019, 5:45PM, at the shelter in Winnebago Park.
