Work is subject to the following City and State of Wisconsin requirements, **Sec.38-EXCAVATIONS: PERMIT REQUIRED**. No person shall make, or cause to be made, any excavation or opening in any street, alley, highway, sidewalk or other public way within the City without first obtaining a permit from the Director of Public Works and Utilities or the Building Inspector.

INSURANCE IS REQUIRED. Prior to commencement of excavation work, the permittee shall furnish the Director of Public Works and Utilities or the Building Inspector satisfactory written evidence that insurance is in force and will be maintained during the life of the permit and the period of excavation. Public liability insurance, bodily injury of not less than \$500,000 for one person, \$500,000 for one accident and property damage of not less than \$1,000,000. **PENALTIES**. Any person violating any provision of this chapter, including those provisions of the WI Statutes, WI Admin Code, or other materials, which are incorporated by reference, shall, upon conviction thereof, be subject to a penalty as provided in SS25.04 of this Code of Ordinances. **\$250 for first offense.**
